

## Sanitary measures – Europe Show 2018 – Herning, Denmark

#### For all sections:

- All entries must wear an official identification of an EE member country. The identification rules of the individual countries are applicable.
- Every breeder must hand in a health certificate when delivering his animals.
- All bird species must originate from a district where there were no outbreaks of Newcastle Disease or Avian Influenza for at least 30 days before the transport to the Europe Show. Birds from affected or restriction areas are not allowed on the grounds of the exhibition centre.
- Animals from third countries cannot be sold.

#### **Poultry section:** (chickens, ducks, geese, turkeys, guinea fowl, pheasants, quail, partridges)

- The animals cannot originate from a breeder where Newcastle Disease (ND) or avian influenza has broken out less than 30 days before the animal transport.
- All gallinaceous birds (not water fowl) must be vaccinated against Newcastle Disaese (ND). The vaccination certificate must state the vaccination validity period.
- Vaccination is only valid from the 28th day after vaccination until the manufacturer's prescribed date of revaccination (generally 1 year for inactive vaccines). The vaccine must have a permit for the species in question and the term must be respected.
- Poultry from non-vaccinating countries may be exhibited with permission of their official veterinary authorities.

#### **Pigeon section:**

- The animals cannot originate from a breeder where Newcastle Disease (ND), Paramyxovirosis or avian influenza has broken out less than 30 days before the animal transport.
- Pigeons must be vaccinated against Paramyxovirosis, respecting the prescription of the manufacturer of the vaccine.

### **Parakeets and parrots:**

- The animals cannot originate from a breeder where Newcastle Disease (ND), avian influenza or Psittacosis has broken out less than 30 days before the animal transport. (Psittacosis: 2 Month quarantine period after the last diagnosed case).
- Decisive are the official regulations of the country of origin for species of European or Guyana Fauna or those on the CITES Appendix A.

In order to standardize the work of the organisation, the exhibitor agrees to use the official documents.
